### Who can take advantage of these tax credits?

Business and Individuals who are at least one of the following:

- \*Sole Proprietorship
- \*Partner in a legal Partnership
- \*Operator of a farm
- \*Member of a Limited Liability Company
- \*Owner of a rental property
- \*Recipient of royalty income
- \*Shareholder in an S-Corporation

### How do you donate to receive your tax credit?

1. Make a contribution to NWMEF
2. Complete and return a notarized tax credit application that we'll send you.
3. The MO Department of Economic Development will issue tax credits to you, which can be filed with your tax return.
