## Winery/Distributor Information

**Keep this sheet for your records**

- Booth size is 12x12, furnished with two 8 ft. tables, two chairs, a pitcher of water, tub and Ice (ICE will be brought to you throughout afternoon as needed).
- Coverings or awnings are NOT provided. Because this event is outside, we HIGHLY encourage a popup canopy. As we know, it can be hot and windy or cold and rainy in September! So, COME PREPARED and bring weights for that canopy!
- The outdoor area is well lit during the day however you will be responsible for your own lighting in the evening and for your own extension cord (up to 100ft). Power will be provided free of charge if requested.
- Unlimited number of wine samples will be offered by the wineries. Sale of wine by the glass, bottle and case is allowed/encouraged. Please bring enough wine to ensure you have enough for the entire festival. Based on past events, we expect around 1,500-1,800 to be in attendance. Wine tasting glasses will be provided.
- You are asked to furnish 2 Spirit items for our Raffle Fundraiser Basket held at 6:30 during the event. . Someone will come by your booth prior to opening and request your donation.
- Festival Hours are 11:30 am-7:00 pm with booth set-up beginning at 8:00 am. We ask that you be ready by 11:00 am. We will assist with unloading plus make the unloading available next to your booth.
- All spirit distributors will be **responsible for obtaining appropriate license from the STATE for sampling (catering) and sales. The City of Mound City & Holt County liquor license applications for a Caterer's Permit are enclosed and will be paid for by the Winefest Committee.**

***Please note the following:***

- Applications should be **completed, signed, notarized (City permit) and returned to Amanda by August 15, 2025.**
- A Statement of **"No Sales and Use Tax Due"** letter from the MO Department of Revenue must be attached to the applications and must be dated within 90 days of the event.
- For a Caterer's permit the applicant is to include a copy of their current **State liquor by the drink license.**
- Once the permits are approved, you will receive a letter of approval for submittal along with your State permit applications. You will need to get your application in to the State as soon as possible. There is usually at least a 10 day turn around for receipt of the State permit.
- Once you obtain your **State Caterer's Permit, please send** it along with a **copy of your insurance** to Amanda prior to Winefest.
